**Dear Sir / Madam,**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Company has received on 02.04.2026 an amendment to an existing service contract from Integral Coach Factory (ICF), Chennai.

The amendment pertains to an increase in the contract quantity from 100% to 125% (i.e., 25% quantity enhancement) for hiring of forklift trucks along with drivers, fuel, and associated staff. The revised total contract value stands at approximately ₹6.33 Crores (inclusive of GST), and the contract period has been extended up to July 24, 2026.
